**AIRPARK RULES (SUMMARY)**

**FLIGHT OPERATIONS**

- Adhere to all applicable FAA regulations.
- Be familiar with and adhere to all traffic patterns whenever below 600 ft. AGL and within 1/2 mile of the Airpark.
- Flying is not permitted from 30 minutes after sunset until 30 minutes before sunrise.
- No person may fly with a passenger unless that person has at least a Sport Pilot license or an Ultralight Instructor rating.
- No person may operate an aircraft solo unless he has been approved for such operation by a club officer or instructor.
- No person may operate or ride as a passenger in an aircraft unless that person has signed a Release and Waiver form.
- Aerobatics are not permitted within one mile of the Airpark unless authorized by a club officer.
- No person may operate an aircraft while under the influence of alcohol or drugs.
- Make every effort to avoid disturbing our neighbors. Stay well clear of homes, businesses, vehicles and farm animals.

**GROUND OPERATIONS**

- Ground vehicles may not be driven on a runway without prior authorization of a club officer.
- No aircraft or vehicle may be parked within 50 feet of a runway. All unattended aircraft must be properly tied down.
- Be careful with propeller blasts. Do not direct blasts toward people or other aircraft.

**GENERAL**

- Be familiar with and adhere to all rules specified in the Rules Manual.
- No alcoholic beverages may be consumed at the Airpark during flying hours.
- Any accident resulting in injury while flying at, to or from the Airpark must be reported to a club officer as soon as possible.
- Guest pilots may be permitted to fly at the Airpark on an infrequent basis provided a current signed Waiver form is on file.
- Each club member is responsible for ensuring that guests are briefed and adhere to all club rules.
- Pilots are ultimately responsible for the safety of their operations. Nothing in these rules should supersede that responsibility.
- The use of good judgment is expected in situations not covered by these rules.
